What has been accomplished?

The Top Ten...

- 1. Preliminary planning and design work completed \$1.5M donated for this purpose
- 2. Lending commitments secured \$500M
- 3. Conditional pledges committed \$70M
- Rim Country Educational Foundation formed received \$50,000 in donations of the required \$500k for predevelopment costs
- 5. Key corporate partnership arrangements identified R & D investment



What has been accomplished?

The Top Ten...continued

- 6. Blue Ridge Water pipeline approved construction starts in 2012
- U.S. Forest Service agreement formed direct sale of 300 acre property at appraised value
- 8. Ancillary property of 60 acres secured four different owners
- 9. A separate legal entity created will hold title, oversee development, and manage the campus project
- 10. Educational partner negotiations advanced ASU and alternative partners

What has been accomplished?

Plus ...Volunteer Support Work

- Planning Committee developed and executed program charter and coordinated volunteer activities
- Marketing & PR Committee prepared press releases, conducted radio interviews, developed website, conducted over 20 community meetings attended by more than 700 people
- Funding Committee formed Rim Country Educational Foundation and initiated friend and fund raising initiatives
- Site Acquisition Expert worked closely with US Forest Service
- Development and Facilities Design Experts researched alternative energy options



What Changes & Challenges?

U.S. Forest Service Requirements and Process	 Multiple governmental agencies Fewer staff available Lengthy, required governmental assessments and documentation




What's Ahead
